A motion was made by Trustee Kelley to approve the minutes from the prior meetings. The motion was seconded by Trustee Prievo and carried unanimously.

Public Comment was held.

Chief Redden reviewed the police report with the Board. It is kept on file at the Police Dept.

Fire Dept. President Hall reported on the monthly activity.

Resolution #18 2025/26

ADOPTION OF THE NYS DEFERRED COMPENSATION PLAN

WHEREAS, The Village of Camden wishes to adopt the Deferred Compensation Plan for Employees of the State of New York and Other Participating Public Jurisdictions (the "Plan") for voluntary participation of all eligible employees; and

WHEREAS, The Village of Camden is a local public employer eligible to adopt the Plan pursuant to Section 5 of the State Finance Law* and

WHEREAS, the Village of Camden has reviewed the Plan established in accordance with Section 457 of the Internal Revenue Code and Section 5 of the State Finance Law of the State of New York; and

WHEREAS, the purpose of the Plan is to encourage employees to make and continue careers with The Village of Camden by providing eligible employees with a convenient and tax-favored method of saving on a regular and long-term basis and thereby provide for their retirement;

* A local public employer eligible to adopt the Plan pursuant to Section 5 of the State Finance Law includes: a county, city, town, village or other political subdivision as defined in Section 131 of the retirement and Social Security law or civil division of the State; a school district or other governmental entity operating a public school, college, or university; a public improvement or special district, a public authority, commission, or public benefit corporation; or any other public corporation, agency or instrumentality or unit of government which exercises governmental powers under the laws of the State.

NOW THEREFORE, it is hereby:

RESOLVED, that the Village of Camden hereby_adopts the Plan for the voluntary participation of all eligible employees; and it is further

RESOLVED, that the appropriate officials of The Village of Camden are hereby authorized to take such actions and enter such agreements as are required or necessary for the adoption, implementation, and maintenance of the Plan; and it is further

RESOLVED, that the Administrative Services Agency is hereby authorized to file copies of these resolutions and other required documents with the President of the State of New York Civil Service Commission.

A motion to adopt Resolution #18 of 2025/26; Adopting the NYS Deferred Compensation Plan, was made by Trustee Prievo. Trustee Kelley seconded the motion.

Mayor Oatman proposed the development of a property tax cap override law. Trustee Prievo made the motion to hold a public hearing for the proposed Local Law, titled "Property Tax Cap Override" on December 9th at 5:30 p.m. The motion was seconded by Trustee Prievo and was carried unanimously.

Public Comment held.

At 6:48 p.m. Trustee Prievo made the motion to enter into executive session to discuss the medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal, or removal of a particular person or corporation. The motion was seconded by Trustee Kelley and carried unanimously.

At 7:13 p.m. Trustee Kelley made the motion to adjourn from executive session and reconvene to regular board meeting already in session. The motion was seconded by Trustee Scoville and carried unanimously.

A motion was made by Trustee Prievo to pay all audited bills on Abstract #7 in the amount of \$132,927.48; inclusive of capital project payments, totaling \$5,735.00. The motion was seconded by Trustee Kelley and carried unanimously.

A copy of the Treasurer's report was submitted for the Board's review and approval. A motion was made by Trustee Kelley to approve the report as submitted. The motion was seconded by Trustee Prievo and carried unanimously.

The October bank reconciliations were submitted for the Board's review and execution. A motion was made by Trustee Scoville to approve the statements as submitted. The motion was seconded by Trustee Prievo and carried unanimously.

Clerk Carver presented the 1st payroll register of November for the Board's review. A motion was made by Trustee Scoville to execute approval of the submitted register. The motion was seconded by Trustee Kelley and carried unanimously.

As there was no further business to discuss, a motion to adjourn at 7:14 p.m. was made by Mayor Oatman. The motion was seconded by Trustee Prievo and carried unanimously.
