#### ARTICLE I Forest Park

**[Adopted 2-7-1977 as Ch. 41 of the 1977 Code]**

#### § 105-1. Use regulations.<sup>1</sup>

No person shall, within the limits of Forest Park:

- A. Operate a motor vehicle in violation of any traffic regulations promulgated by the Village Park Commission who are delegated pursuant to § 1603 of the Vehicle and Traffic Law authority to exercise by official order, rule or regulation the following powers granted to the Board of Trustees in Article 39 of the Vehicle and Traffic Law subject, however, to the limitations imposed by §§ 1645 and 1684 of the Vehicle and Traffic Law:
  - (1) Prohibit or regulate the operation and the stopping, standing or parking of vehicles in public parks.
- B. Have in his or her possession, or consume, any alcoholic beverages, except that groups and organizations may, between the hours of 10:00 a.m. and 9:00 p.m., possess or consume alcoholic beverages, provided that such group or organization shall have obtained permission therefor from the Village Board prior thereto; it is provided, further, however, that no permission shall be granted unless the Village of Camden is provided with proof of liability insurance in an amount of not less than \$100,000 issued to such group or organization wherein said Village of Camden is named as an additional insured. **[Amended 5-17-1982 by L.L. - C. Build or light any fire except in a designated location or in a metal grill.
- D. Permit a fire to burn unless under the supervision and care of a person over 18 years of age.

- E. Deposit or leave trash, garbage or any other articles except in waste receptacles provided therefor.
- F. Build or erect any building or structure except with permission of the Village Park Commission.
- G. Damage, mar, cut, carve or deface in any manner any tree, table, bench, fireplace, grill, building or structure.
- H. Operate a motor vehicle unless the same be licensed, which licensed motor vehicle operation shall only be permitted between the hours of 10:00 a.m. and 9:00 p.m. of each day and only on the paved roads. The only exception to these hours shall be by permission of the Forest Park Commission. [Added 5-17-1982 by L.L. No. 3-1982]

**§ 105-2. Penalties for offenses. [Amended 5-17-1982 by L.L. No. 3-1982<sup>2</sup>]**

Any violation of any provision of this article shall be punishable by a fine not to exceed \$1,000 and, where appropriate, by restitution being ordered.
